Charnwood Primary Academy is committed to protecting the privacy and rights of anyone who chooses to share their personal data with us. This means that, under the GDPR, we must have a lawful basis for processing this data and have obligations to keep this data secure. We collect special category data in order to fulfil our legitimate interests as a public organisation, where we have a legal obligation to process this data or where we have consent.

The Academy requires your consent to collect the data specified on the Recruitment Monitoring Form as:

Providing this data is not obligatory, however, should you wish to provide this data for the Academy, we require your consent. To provide your consent to our collecting of this data, please sign in the box entitled 'Consent' at the bottom of the page.

Should you wish to provide the information outlined above, this will be utilised in accordance with the Staffordshire University Academy Trust's Data Protection Policy and Compliant Records Management Policy. This data will be accessed by approved Academy personnel and stored in a secure manner physically and also electronically in the Academy's Management of Information System, called SIMS. This is provided by a company called Capita.

Upon the withdrawal of your consent to process data of this nature, no further processing will be undertaken.
